- **1. Apologies** William Wrinch and David Wood.
- **2. Declaration of Interest** Simon Leatherdale.

- **4.** Matters Arising 1. Phone box SL hasn't go the glass yet. Clerk hasn't found out what power supply is needed for a defib. **2.Clerk** still trying to find out how to encrypt data. **3. SL** had drafted a notice for the parish magazine, ref. fitness equipment.
  - **Adjournment DR** -With reference to talk of a merger between Babergh and Mid Suffolk, David said that the opposition and about 9 conservative councillors, opposed the merger, mainly over the wasted costs in time and money it would instigate. In view of this there would now be a referendum. Council also voted to remove the leader due to her lack of actgion, listening and understanding of council matters. She resigned. A new leader John Ward was appointed in an election and he appears to be more on the ball and has promised a lot of improvements, particularly in the housing area. It's hoped he will be better at communicating with opposing parties.

Builders have offered to make it good, but landowner not interested.
